DELEGATION OCTOBER 17, 2023: CORRESPONDENCE – Mr. JAMES BISSON

On Wed, Oct 11, 2023 at 11:57 AM James Bisson Hi Ron,

wrote:

The purpose of the delegation is to review changes to the 2022 report vs the 2021 report regarding crime stats and the financial information in the 2022 report.

The 2021 format providing details on crime stats had been consistent in all the reports I looked at since 2014. Unfortunately, that was replaced by 3 broad measurements that provide direction rather than detail. I would like to suggest that the table format be retained in future reports.

As for the financial report, it's embarrassing to be honest!

- The Facilities row has a \$2 million entry in the 2022 Actuals column instead of \$200k.
- It's obvious someone was manually entering the numbers. Your bottom line for the Actuals column simply doesn't add up.
- The last 2 columns in the report are showing mostly negative percentages. They should all be positive as every category increased.

Here's where I get.... a little upset!

This report was reviewed by the Chief, Deputy Chief, Staff, your Board, and was presented to Council and NOBODY SAW THIS??!! Makes you wonder if anyone actually read it.

I watched the video of the Chief presenting the report to Council. He said a few things I think were way off and one I found pretty offensive, but that's debatable. He does deserve at least a little scrutiny for the communication if not the outcome of the results, no? The entire Council lauded him with praises including the two who sit on your Board with very little if anything asked regarding the presentation, including a \$2 million dollar mistake in plain view!

I would appreciate your input on this as this is puts into question the competency and oversight of our officials in the eyes of the public.

Hi Ron,

I'm including Sean in the chain as I would like to know if my delegation will be accepted as the deadline has passed. More than happy to discuss prior, but I'm prepared to address these issues one way or another. You permit only 10 minutes for presentations, so the delegation is very limited compared to what I've looked at.

• The increase in spending that occurred in 2022 vs. 2021 is astounding! 20% Year over Year!

•

 The Tax Levy Allocation difference between the Actual and Budget for 2021 was \$2 and \$143 in 2022. No one can come that close randomly two years in a row with the size of numbers being worked with. These numbers are for political purposes, not results that are designed to be analyzed and justified.

•

- The amount of Recoveries jumped by approx. \$1,400,000 to cover expenses in a single year. I've never seen a public service provider self fund to that degree. If that's the case you don't need as much taxpayer money.
- On the average tax bill, the police service costs almost as much as fire and road repair combined. Attached
- The fact that V13 reports directly to the Chief is disturbing. He's supposed to be dealing with law enforcement, not being a venture capitalist. see Structure attachment
- At the presentation to Council in August, the Chief said 3 times and I quote, "I have an easy
 job!". I can see why he would say that when apart from V13 he only has 2 people reporting to
 him! see Structure attachment. Hope the level of issues we're facing doesn't stress him out too
 much.
- The Chief doesn't live in Cobourg even though he publicly stated he would move here when he
 got the job. Neither does the Deputy Chief!! Don't pay taxes here, don't see what goes on after
 they go home, don't spend here, don't have neighbours here that have alot of stories. Being
 among the top paid municipal officials, I don't think it's because they can't afford it.
- The Chief has dismissed community concerns about safety as us "feeling uncomfortable" rather than unsafe based on the stats. Your own 2022-2025 Strategic Plan (that's another story) shows a significant drop in approval ratings with the major elements driving the trend being law and order issues while non violent crime is up. If he lived here he might see it differently!
- The Encampment to be continued
- I suggest you look at the Epoch Times article on Cobourg. With the amount being spent they
 could have fixed the door at the Police Station alot sooner! No one made a statement? Ouch!

- The service hires a large contingent of constables using its tiered model, yet non-violent crime is up 15%. I've not found the Chief being asked that question let alone use the resources to get a police presence out there.
- The Chief doesn't want to put out the names of local offenders publicly is my understanding. He's lucky he'll never see them where he lives, but our local residents and businesses will.






For residential taxpayers in Cobourg, this year's tax rate of .0084929 represents a 2.80% increase from the 2021 tax rate.

Background

The 2023 operating budget of the Cobourg Police Service (exclusive of business center operations) is \$10,017,664. To support this, the service received about \$6,993,772 from the Town of Cobourg through the Tax Levy. 




The suspect vehicle, described as a black Ford Mustang was last seen heading north on Spring Street, driving with its lights off.

No injuries were reported, and no one was in the building at the time of the incident. The investigation continues at this time.




- There were ten (10) reports of frauds (including identity theft) in the month of September, which was an increase of three incidents from August.







INVESTIGATIVE OCCURRENCE

Weapons/Mischief: The Cobourg Police Service received reports of a group of unknown people in a black car that had been firing a cap gun out the window of their vehicle as they drove. No license plate or further description for the vehicle was received; however, officers on patrol were able to locate the vehicle on Division Street. The vehicle was pulled over and the youth occupants were spoken to and cautioned for their actions.

Fire: While on general patrol officers observed smoke coming from the wooded area east of Division Street. No persons were observed to be in the area of the fire, which had begun to spread slightly. The officer attempted to put the fire out with an extinguisher, during which time Cobourg Fire arrived on seen and took over extinguishing the fire. The By-law officers were notified and were planning to follow up.

Unwanted: Officers were dispatched to a property in the downtown area where the homeowner was operating an AirBNB. The owner reported that additional guests that had arrived without authorization. All guests were reported to be rude and argumentative and refusing to leave. Police arrived on seen and educated the parties on the *Trespass to Property Act* and the unwanted guests were ordered to leave the property.

Motor Vehicle Collision: Police were dispatched to the area of Division Street for a report of a pedestrian being struck by a motor vehicle. Police arrived on scene and located the pedestrian in the care of paramedics. It was learned that the pedestrian was walking in a designated crosswalk when a driver turning onto Division Street struck the pedestrian. The pedestrian was transported to Northumberland Hills Hospital with minor injuries and the driver was charged with Careless driving.

Fail to Remain: Police received a call for a vehicle that left the roadway and struck a light standard on King Street and failed to remain on scene. The police were then dispatched to an area nearby for a report of two males exiting a vehicle that was apparently dragging a light standard under their vehicle. Officers arrived and noted the driver to be unsteady on his feet and showing obvious signs of impairment. The light post was still lodged under the front end of the vehicle. The male party was arrested.

Motor Vehicle Accident: Police responded to a business on Burnham Street for a report of a vehicle that had struck the front of the building. Officers located a male who was experiencing a medical episode who had accidently engaged the gas pedal causing the incident. The male party did not suffer any injuries and was left in the care of family.

Fire: Police while on general patrol detected smoke coming from the rear of a business located on Covert Street. A fire had broken out in the rear of the building that was large enough where officers were unable to extinguish the fire. The Fire Department was contacted and responded to the scene.

Suspicious Person: Police attended a financial institution for a report of a male trying to open a bank account while using what branch staff deemed suspicious identification. The male party attempted to flee the scene while officers attempted to confirm his identity. After a short foot pursuit, officers managed to arrest the male who was charged accordingly.

Mischief: Police were dispatched to a disturbance in the Division Street area where the complainant advised his vehicle had been damaged by an unknown male kicking a garbage can at it. Police located the male in question and found him to be in a manic state. Officers apprehended the male who was then transported to Northumberland Hills Hospital for a mental health assessment.

Mischief: Police responded to an address in the west end area for reports of their vehicle tire being slashed with a knife. Police were able to positively identify the suspect from CCTV, who was located and arrested a short time later.

Robbery: Officers responded to a church parking lot for a report of a male who had been a victim of a robbery with violence while he waited for his children. Officers were able to recognize the description of the suspect who was arrested a short time later in the area. During the course of the arrest the suspect spat on the arresting officer. The suspect was charged and held for a bail hearing.

Disturbance: Police officers, while on general patrol, witnessed a street race between two vehicles travelling east on Elgin Street. Police initiated a traffic stop on one of the vehicles and charged the driver with race a motor vehicle. The vehicle was impounded, and the drivers license was suspended.

Mischief: Police responded to a call at 11:43pm for a report of a loud noise coming from a construction site. Upon arrival police located a male known to them inside the onsite porta-potty. The door to the porta potty had been pried open and there were obvious signs of damage to the door and lock. Through investigation it was revealed that the suspect had been released with conditions not to be in the Town of Cobourg, as well to remain in his residence between the hours of 9pm – 6am. As a result, the male was charged with mischief and two counts of failing to comply with his release order. Male was held in custody for a bail hearing.

Budget 2024

The Finance Committee engaged in further discussions around the 2024 budget. Several scenarios were presented and discussed with the Chief – The current iteration will be presented on November 29th to the Town Council. The initial ask is a 6.30% upward budget adjustment on the Tax Levy.

RECRUITMENT

Special Constable

We are pleased to announce that Melissa Long and Nick Daigle will be starting with us on October 23rd as P/T Special Constables. Nick was previously a By-Law Officer with Town of Cobourg, and Melissa has a wide range of experience in several roles. Both individuals went through a robust recruitment process to include elements such as a Psych, Fitness and Background check.

DIVERSITY, EQUITY, and INCLUSION

The "Diversity Meter" closed on September 29th. At closure we had 65 persons (out of an eligible 110 individuals) completing the survey from the following employee groups: -

Uniform: 17 persons

Civilian: 65 persons

The participation level was just under 60% of the total employee count eligible to participate. A report will be forthcoming.

DISABILITY MANAGEMENT

As we did for 2023, DM costs will form part of our 2024 Budget Presentation. Currently, we estimate that these costs to be just under \$1.6M for the upcoming year. We are currently working on several initiatives to bring awareness and increase advocacy on the financial resourcing impact of this portfolio particularly on small services that have limited revenue sources. Information will be shared with the PSB in the coming weeks.
