## Why Tiny Homes?

- Habitat's vision is a world where everyone has a decent place to live
- Tiny homes are an opportunity to:
  - Increase quantity of affordable housing
  - Partner towards Habitat's vision
  - Broaden range of housing options
  - Replicate success
- COVID-19 has increased urgency to respond to the local affordable housing crisis

#### Tiny Homes are not new to Canada

Current trend, but not new

Wartime housing still exists in Northumberland

...<u>but</u> no longer affordable

Ontario building code accommodates Tiny Homes



Suitable for construction anywhere in Canada. Area—660 sq. ft. Cubic contents—15,180 cu. ft. 5½ Rooms, including Living-Dining Room, Kitchen, 3 Bedrooms and Bathroom.



# **TTHN's vision for Tiny Homes**

#### Our vision is....

- Permanent micro-community
- Affordable homeownership or equity building housing
- 650 ft<sup>2</sup> or less



#### Our vision is <u>not</u>...

- Temporary or on wheels
- Warehousing of people



### Did you know?

Ontario municipalities are getting ready for Tiny Homes The Region of Waterloo is initiating two new affordable housing projects, offering land as an incentive

Peterborough Council has created a task force to prepare a plan to address their housing crisis, including the creation of tiny homes

The Township of Leeds and the Thousand Islands amended its zoning by-law to accommodate tiny homes

The Township of Edwardsburgh-Cardinal has an Official Plan that includes tiny houses as part of full range of affordable housing types

## Did you know?

Ontario municipalities are also partnering with local Habitats to develop Tiny Homes Kingston – City of Kingston is partnering with Habitat for Humanity on a pilot project of up to 8 micro living spaces/tiny homes. City is contributing the land and \$646,000 in funding to cover soft costs/infrastructure costs for the development.

Sarnia – Habitat Sarnia and the organization SMALL (Sarnia Making Affordable Living in Lambton) have partnered with the City of Sarnia to possibly develop tiny homes on a piece of land donated by the city to the project.


#### **Our Objective**

  - Single parcel of land
  - Developed to accommodate several living spaces
  - Common buildings with shared outdoor space
  - Diversity of ownership and community interactions

## Alignment with Policy

#### Tiny homes support the Provincial Policy Statement

- Supports housing targets
- Contributes to the range of housing options and densities
- Efficient use of resources



## Alignment with Strategy

#### Tiny homes support the Northumberland and Cobourg Affordable Housing Strategies

- New housing should include units for persons living alone
- Increase supply by using partnerships
- Encourage diverse housing stock, including smaller units
