6. BUSINESS ARISING

6.1 COVID-19

1) Proof of Vaccination requirements as of September 22, 2021

Libraries have not been identified as a setting where proof of vaccination is required.

However, Gores Landing and Bewdley, may be impacted by the regulations, as they are in a rental space, and a recreation centre, respectively.

Information was received yesterday that seems to clarify that the regulations may not be applicable to Libraries in a recreational facility for individuals who are solely entering the centre to access the Library the patron is not required to show proof of vaccination. This would help with the Bewdley branch.

Gores Landing is a rental facility, however during the time that the facility is being rented for the purposes of providing library service, patrons are not required to provide proof of vaccination.

Clarification has been received from the Ministry of Tourism Culture and Sport.

The Town of Cobourg is currently working towards a vaccination policy for Town of Cobourg employees.

There are a number of libraries in Ontario that have passed a vaccination policy for their employees.

Recommendation from T. Robinson is to create a vaccination policy for employees of the Cobourg Public Library, using the Town of Cobourg's vaccination policy for employees as a framework.
