#### 2022 Budget Referrals:

1. Motion from the Committee of the Whole meeting regarding the Phase 3 Safe Restart Agreement Transit Proposal for the Town of Cobourg Public Transit System

Resolution 124-21 Moved by Councillor Brian Darling Seconded by Councillor Aaron Burchat

WHEREAS at the Committee of the Whole Meeting on March 29, 2021, Council considered a Memo from the Director of Public Works, regarding the Phase 3 Safe

Restart Agreement Transit Proposal for the Town of Cobourg Public Transit System;

NOW THEREFORE BE IT RESOLVED THAT Council direct Staff to implement an online payment and contactless smart card transit pass system from TransitFare & Systems Ltd. in the amount of \$20,000.00 including HST; and,

FURTHER THAT the maintenance, data and hosting fees in the amount of approximately \$5,000.00 be funded in the 2022 Public Works Transit operating Budget.

2. Motion from the Committee of the Whole meeting regarding the amendment to By-Law No. 022-2016 – Fish Cleaning on Municipally owned Property

WHEREAS at the Committee of the Whole Meeting on June 21, 2021, Council considered a memo from the Assistant Manager, Waterfront Operations, regarding the amendment to By-Law No. 022-2016 – Fish Cleaning on Municipally owned Property;

NOW THEREFORE BE IT RESOLVED THAT Council support and endorse the Amendment to By Law No. 022-2016 which would prohibit the cleaning and disposal of waste from preparing fish on Municipal property; and

FURTHER THAT the Amendment of By Law No. 022-2016 shall govern Waterfront Grounds and Infrastructure, Municipal Parks, Properties and Bridges; and

FURTHER THAT Council direct Staff to prepare a report to Council to be brought forward at the 2022 budget deliberations on the anticipated costs to incorporate adjustments to the Cobourg Marina Fish Cleaning Station; and

FURTHER THAT the Cobourg marina fish cleaning station be removed at the passing of the by-law for a period of one (1) year from May 31, 2021, and upon final review by Council of the Staff report.

3. Memo from the Director of Public Works regarding information on Electric Vehicle Charging Stations

WHEREAS at the Committee of the Whole Meeting on July 19, 2021, Council considered a Memo from the Deputy Director of Community Services regarding the Parks & Recreation Advisory Committee's Review of Victoria Park Beach;

NOW THEREFORE BE IT RESOLVED THAT Council endorse the Parks and Recreation Advisory Committee's recommendations as outlined in the Staff Report; and

FURTHER THAT an internal Working Group be established – including a cross-section of staff with expertise regarding parks, communications, events, parking, legislative services, by-law enforcement, emergency planning/response, economic development and with Council representation – to enhance collaboration in the management of the waterfront, including Victoria Park Beach, the Cobourg Harbour and the West Beach; and

FURTHER THAT this report be shared with the Working Group and all relevant departments to review, implement, and to provide any recommendations to the 2022 budget process.

### 5. Motion from the Committee of the Whole regarding the (Re)Naming of the West Headlands/Pier

WHEREAS at the Committee of the Whole Meeting on August 23, 2021, Council considered a Memo from the Accessibility Coordinator regarding the (Re)Naming of the West Headlands/Pier;

NOW THEREFORE BE IT RESOLVED THAT Council adopt the colloquial name of "The West Headlands" for the area described as the West Headlands/Pier until the Stewardship Study is completed, and; FURTHER THAT the renaming of the entire West Headlands, Pier, and Beach area should be referred to the Parks and Recreation Advisory Committee for further consideration at the time of completion of the Stewardship Study keeping in guidance with the 9 Town of Cobourg's Naming Policy and recommendations from our Indigenous community, and;

FURTHER THAT a full audit of historical names of areas in Cobourg be undertaken to ensure that we are not unintentionally impacting our Indigenous community, and:

FURTHER THAT Council consider adding funding in the 2022 budget for the entirety of the Town of Cobourg staff members, Board and Committee

Members, and other volunteers to participate in Indigenous Awareness training.

6. Memo from the Accessibility Coordinator regarding the Town of Cobourg's Equity, Diversity, and Inclusion Strategy

FURTHER THAT Council provide input into the Equity, Diversity, and Inclusion Strategy to the Accessibility Coordinator over the next three (3) weeks, and;

FURTHER THAT Council direct Staff to bring a budget to the 2022 Budget deliberations related to the costs associated with the Equity, Diversity, and Inclusion Strategy, and;

FURTHER THAT Council direct Staff to bring the final version of the Equity, Diversity, and Inclusion Strategy for the Town of Cobourg to a future Council meeting before the end of 2021.

FURTHER THAT Council consider incorporating funding for further youth engagement in the 2022 Budget to raise awareness of opportunities for youth to participate.

NOW THEREFORE BE IT RESOLVED Council direct the Chief Administrative Officer to pursue the recommendations proposed by staff in Section #1) Staffing Adjustments, with the amended direction to the Chief Administrative Officer; and,

FURTHER THAT Council direct the Chief Administrative Officer to pursue the recommendations proposed by staff in Section #2) Organizational Realignment as presented; and

FURTHER THAT Council direct the Chief Administrative Officer to pursue the recommendations proposed by staff in Section #3) Enhancement to the Town's policy environment to right-size decision making processes, and the Town's operating processes and ways of working; and

FURTHER THAT Council direct staff to bring forward all items related to these Council approved recommendations to the 2022 Municipal budget; and

FURTHER THAT Council direct the CAO to implement the cost reduction and cost savings recommendations, building upon the KPMG Organizational Review Report on Cost Savings Strategies as discussed in Closed Session, to be reflected in the Draft 2022 Budget deliberations to be held in Open Session.
