On November 15, 2021, Staff provided a parking rate increase proposal to Council in response to historical requests for an increase in parking revenue, investigate paid parking opportunities east of Victoria Park and in response to recommendations of the Waterfront Working Group and Parks and Recreation Advisory Committee Beach survey.

6. ANALYSIS

As a result of the November 15 Committee of the Whole meeting, Staff were to circulate the proposal to the Transportation Advisory Committee (TAC) and DBIA and report their comments back to Council on December 6th.

Following the November 15th meeting, Staff did circulate the proposal to the above groups as well as the Waterfront Working Group who then met to discuss the proposal on November 22nd.

A notice summarizing the proposal and providing a link to the full report was also delivered to all addressed within the neighborhood to the east of Victoria Park.

A notice summarizing the proposal and providing a link to the full report was also emailed to all members of the DBIA.

Staff have received numerous comments from residents and from the DBIA and is recommending to Council that all comments be circulated to the Waterfront Working Group for review and consideration. A meeting of the Waterfront Working Group will be scheduled for the first week of January 2022 to discuss the comments and a report will be prepared for Council with recommendations from the Waterfront Working Group by January 13th when reports are due in advance of the January 24th Committee of the Whole meeting.
