Privacy Breaches and the Protection of Personal Information

Municipal government institutions must adhere to a variety of privacy-related obligations under the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA). Failure to follow these requirements may result in a privacy breach, which occurs when personal information is collected, used or disclosed in ways that do not comply with Ontario's privacy laws. Milton's Mid-Rise Buildings Urban Design Guidelines

The Province is expecting municipalities to place greater emphasis on promoting intensification in urban areas across Ontario. Appropriately located and well-designed mid-rise and tall buildings with mixed uses, amenities and community services close to transit, can contribute to healthy and sustainable communities. At the same time, it is evident that introducing taller and higher density built forms in a predominantly low-rise community can also raise concerns about perceived or potential impacts. Milton's urban design guidelines assist with interpreting the general intent and purpose of Official Plan policies and clearly illustrate the features that are desirable for the appropriate development of mid-rise buildings.

David Twigg is a Senior Planner at the Town of Milton. He specializes in Policy and Urban Design; providing advice on a full range of development

Electronic Meetings – The "New Normal" for Municipal Meetings

Bill 197 received Royal Assent on July 21, 2020 as the COVID-19 Economic Recovery Act, 2020. Among other things, Bill 197 amended both the City of Toronto Act, 2006 and the Municipal Act, 2001 to allow members of a council, local board or a committee of either of them to participate electronically in meetings – without the need for the physical presence of any member at a particular location. In this presentation these changes will be discussed with an emphasis on their impact on committees of adjustment and consent granting authorities.
