# **DELEGATION REQUEST**

#### General Nature/Purpose of the Delegation:

The delegation from Cobourg Toastmasters would like to present to the committee our application request for in kind funding to financially assist with the cost of meeting space for the toastmaster club.

#### What do we do?

We provide a safe environment for people to learn, grow and practice their ability to speak in front of others.

Public Speaking is one of the most feared aspects of serving in a public capacity. By easing those fears through the tried and true aspects of the toastmaster program, our members have gone on to serve the Cobourg community and surrounding areas of Northumberland.

We will discuss the merits of the toastmaster program and how that serves the community. We will also present the financial breakdown and how the money will be used.

The cost of an internet capable meeting space in Cobourg is beyond our financial capacity.

The world has changed dramatically in the last two years and in order to better serve the community in an updated capacity we need to upgrade our ability to run hybrid meetings; ie a combination of in person and online attendance.

We are asking for an in kind donation towards the coverage of rent by the Town of Cobourg for use of the Venture 13 facilities.

Venture 13 is a high profile space which will not only elevate the profile of Cobourg Toastmasters, but also allow for us to use the technology to be able to create effective hybrid meetings. Hybrid meetings will also increase our opportunity to include a wider group of people that may not want to or are unable to travel for an in person meeting. Additionally, the space is accessible, reducing physical barriers for anybody to join. Two thirds of the bi-annual membership fees collected are required to be sent to Toastmasters International in the U.S. (Further details in the presentation)

The remaining third is retained by the club for any expenses we have to run the club.
