REPORTING

Chief of Police to the Board with recommendations for employee recognition annually.

Purpose

To establish the principles that form the basis for the recognition and reward of a full time Cobourg Police Service member at their retirement.

POLICY PROVISIONS

- Retirement functions will be jointly planned and organized by the "committee" which will consist of one representative from the Board, Senior Management, Senior Officer's Association and the Cobourg Police Association.
- 2. The cost of the reception shall be shared as follows:
 - Cobourg Police Services Board --48%
 - Senior Police Management ----- 2%
 - Senior Officer's Association ----- 2%
 - Cobourg Police Assocaition ----- 48%
- 3. This Board policy shall apply only to those Cobourg Police Service members who retire after a minimum of fifteen (15) years of continuous service to the Cobourg Police Service.
- 4. The retiring member shall receive a reward of their choosing as outlined in the Diamond Recognition Program, based on their years of service.

The rewards schedule is:

Years of service	Reward Value
15 - 19 years	\$ 300
20 - 24 years	\$ 400
25 - 29 years	\$ 500
30 years plus	\$600

- All members upon their retirement shall also receive a certificate signed by the Chair of the Cobourg Police Services Board recognizing the total years of service.
- 6. Senior Police Management shall notify the Board of an impending retirement three months prior to the retirement.

ADOPTED by Electronic Vote unanimously in the affirmative "YES" March 7, 2023 and Carried.
