## Cobourg Farmers' Market Association Submission to Town Of Cobourg Committee of the Whole

April 3, 2023

First of all, we would like to thank the Town of Cobourg for the use of Rotary Park for the Farmers' Market. Since we moved to this location a few years ago, the market has become a community hub, with vendors enjoying the space and visibility that "The Oval" presents and patrons enjoying a spacious, pretty stroll around the circle while listening to our Buskers and enjoying a chat with their friends and neighbours.

Our meeting recently with town staff has provided us with a special event permit for the season at a very generous rate. We now are faced again with the parking situation. While our members almost exclusively reside within the boundaries of Northumberland County, only a few actually live within Cobourg's town limits. This excludes the majority from the Town of Cobourg's parking permit system.

One option for parking is the permit system where the Town would issue permits to each vendor to be used only for the hours of the Market. This has been a little tedious in the past with occasional day vendors needing permits sporadically and weekly vendors sometimes bringing a different vehicle than the one associated with the permit.

In order to reduce the red tape associated with this system, the Farmers' Market proposes that the lot immediately east of the Rotary Park be excluded from the Bylaw Officer's patrol during the hours of the market. This allows vendors to keep their vehicles close to the market and frees up space in other lots that are closer to King Street. The number of vehicles using this lot daily would number 20 on a low day and up to approx 50 on Artisan market days which occur once a month. We would need access from 7am for setup until 1:30pm to allow packing up.

What the Farmers' Market is proposing is a lump sum payment for the use of the parking lot. Our offer is \$1000 for the season or in kind donations of food to the local food bank or Women's Shelter. The donation amount would be administered by our Market Manager.

Again, thank you for your support and we look forward to seeing everyone at "The Oval" starting in May.
