1. CALL TO ORDER

Deputy Mayor Suzanne Séguin called the meeting to order at 10:03 AM

2. TRADITIONAL LAND ACKNOWLEDGEMENT

Deputy Mayor Suzanne Séguin recited the Traditional Land Acknowledgment statement.

5. 2021 OPERATING AND CAPITAL BUDGET REVIEW

5.1 Protection Services Operating and Capital Budgets

Cobourg Fire Services Budget

Fire Chief, Mike Vilneff and Deputy Fire Chief, Gene Thompson provided an overview of the proposed 2021 Fire Department and Emergency Planning Operating and Capital Budgets. Members of Council raised questions of clarification in regards to the Draft Budget submission from the Cobourg Fire Department.

The Fire Chief and Deputy Fire Chief left the Meeting at 11:33 A.M.

Cobourg Police Services Budget

Cobourg Police Chief, P. Vandegraaf and Cobourg Police Services Board Chair, D. Pepper provided an overview of the proposed 2021 Cobourg Police Service and Police Services Board's Capital and Operating Budgets. The Chief spoke to new special projects, community outreach programs and noted an increase in the operating and capital budget.

After a question and answer period, the Police Chief and Chair of the Board left the meeting at 12:38 P.M.

Building Department and By-law Enforcement Services

G. McGlashon, Director of Planning and Development, and B. Larmer, Municipal Clerk, provided an overview of the Protection Services Operating and Capital Budgets for Building Code Enforcement, Property Standards and By-law Enforcement.
