It was decided that this is not needed as staff will do further testing and have committed to testing in the harbor and will report the findings to the committee

2) Design walkways from the canoe and sailing school compounds to the water's edge that protect citizens who are launching their watercraft.

Received quotes on Monday. The Waterfront Assistant Manager will be contacting GRCA.

Applied for Provincial and Federal Grants for an accessible dock.

3) Devise a means for safe entry into the harbour waters from the west harbour beach that is accessible to those wanting to use the harbour.

Looking at the parking lot to see if we will have to move any parking spaces.
