### 3. PURPOSE

The purpose of this report is to satisfy the legislative requirements of the Municipal Act, 2001 regarding Council remuneration and expense reporting. It satisfies the requirement that this information be made available to the public.

#### **4. ORIGIN AND LEGISLATION**

Section 284(1) of the Municipal Act, 2001 requires the Treasurer of a municipality to provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to,

- a. each member of council in respect of his or her services as a member of the council or any other body, including a local board to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- b. each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a)
- c. each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.

#### **5. BACKGROUND**

The authorization to provide for paying remuneration to the members of council is provided in By-Law 078-2015 as amended by By-Law 037-2018.

#### **6. ANALYSIS**
