6.1.1 Memo from the Deputy Director of Community Services, regarding the Status and Options for Cobourg Victoria Beach for the Summer of 2021.

Tracey Vaughan, Chief Administrative Officer, provided an overview of the report noting that staff are seeking direction for the operation of Victoria Beach for the summer season. Teresa Behan, Deputy Director of Community Services, noted the options available for the operation of Victoria Beach during the summer season are outlined in the staff report.

Members of Council engaged in a discussion regarding the options outlined in the report and the opening of the beach. Questions were raised regarding beach capacity, enforcement, delegated authority to close the beach, fencing, funding to cover additional costs, partial beach closure and additional washroom facilities.
